Question No. 1 40 Marks

Scenario for the presentation: In a 7th semester B.Tech class of size 50 students, there are 32 male students. In a term exam, 27 students have passed in Subject-A, out of which 10 are male students. 11 students have failed in Subject-B, out of which 5 are female students. 35 students including all of the male students have passed in Subject-C. Create a nice presentation describing the Class, pass percentage of different subjects, pass percentage of male and female in respective subjects.

Power point properties to be used:

- 1. Use "Fade" transitions between the slides.
- 2. Slide 1: Title slide: Use appropriate title, author name (your name), and Today's date in the centre of the slide.
- 3. Header: On the top-right corners of all of the non-title slides, show Today's date.
- 4. Footer: On the bottom centre of all of the non-title slides, show "IIT Tirupati".
- 5. Footer: On the bottom right corner of all of the non-title slides, show the slide number.
- 6. Slide 2: Use this as an introductory slide to very briefly describe the scenario being presented.
- 7. Slide 3: Use an appropriate table to show the details of the class including size, male students strength, and female students strength.
- 8. Slide 4: Use an appropriate 3D Pie chart that shows subject-wise pass percentage. Data labels should be shown. Mouse over to each pie should show the subject name and value. Apply 5% pie explosion.
- 9. Slides 5, 6, and 7 (for respective 3 subjects): Use appropriate 2D column chart (with trend line) to show subjectwise male and female pass percentage.
- 10. Slide 8: Last "Thank You" slide, create a composite (grouped) shape consisting of overlapped Triangle, rectangle, and circle. Animate this composite shape and move this shape in an S-shaped fashion (inside the slide area). Subsequently, a "Thank You" Word Art text with outer right shadow, has to be animated in a "fly in" fashion into the slide (from outside to the centre of the slide).
- 11. Along with the power point slide source and other excel data files (if any), also submit the PDF version of the final presentation.
- 12. Using notes section of the slides, create notes in each of the slides, explaining the information and data computed in the slides.

Note: i) Cosmetic details of the presentation will carry weightage. ii) Accuracy of the chart, and data used will carry weightage.

By extending the columns for deductions please prepare the salary bill Dearness Allowance is payable at 9% of the 7th (Seventh) CPC Basic pay Director is contributing 8.3% of his 7th CPC Basic pay as Provident Fund All the Professors are reemployed. Hence there is no P.F. For Associate Professors and Assistant Professors, an amount equal to 10% of their 7th CPC basic pay has to be deducted towards New Pension Scheme (NPS) Under deductions the following deductions may be made:

- 1) Profession Tax Rs.200 for all the Officers
- 2) Income Tax at 20% of the Basic pay for all officers.

Arrive at the total deductions and by deducting the total deductions from the Gross Salary arrive at the net salary for the above officers.

For Director Free furnished accommodation is provided. Hence no HRA. For all other Officers HRA @10% of the 6th CPC has to be paid.
