During the demo, *Mr. S Anjaneyulu, Junior Superintendent (Purchase & Stores)* was also present. Upon completion of the demo, observations and recommendations of the technical committee are summarized below.

The company/bidder was able to successfully demonstrate the feasibility of the integration of various audio and video equipment with appropriate explanations. They are also able to explain the various interconnections aspects among the devices for various meeting room setups. Their performance was found to be satisfactory, and hence, the concerned bidder is recommended for the next stage.
- 2. The firm/company M/s. Gurusons Communications Private Limited provided the demo of the AV equipment as per the tender norm. The company/bidder was able to successfully demonstrate the feasibility of the integration of various audio and video equipment with appropriate explanations. - 4. The firm/company M/S. Genesis India Pvt Ltd provided the demo of the AV equipment as per the tender norm. They are able to meet the functionality of the AV solutions as per the tender norms. However, the AV committee was having concerns related to one of the OEM's presence in India for some of the components. One of the tender clauses is: "The OEM for all main components of the tender (viz. Display, Video Switchers, Microphones, Speakers, Mixers, Audio DSP) should have a direct presence in India for a period of 3 years, as per the requirement notified in the ATC document." Upon follow-up with the concerned firm/vendor, and based on the document supported by M/s Genesis India Private Limited, the submitted OEM authorization had clearly stated that M/s. Liberty AV Solutions, USA had authorized only M/s. Anixter India Private Limited, Chennai as an authorized importer and Service provider for Liberty equipment. Thus, as M/s Genesis India Private Limited is not an authorized importer of Liberty AV Solutions, it is not possible to allow them to participate in Liberty AV Products. Hence, the concerned firm/bidder is not recommended for the next stage.
